<p><u>2019 PDCM-VBR – <i>No Longer Available</i></u></p> <p>Metrics in 2019 were:</p> <ul style="list-style-type: none"> • Earn an additional 5% on E&M Codes • Measurement year Jan.1-Dec. 31, 2018 • Payment period 9/1/2019-8/31/2020 • 3% Engagement rate (2 touches) required • At least 1 PDCM code must be billed across the entire practice to have PDCM related codes (99495, 99496, 1111F) counted towards engagement rate. 	<p><u>NEW - PDCM-Population Management VBR</u></p> <ul style="list-style-type: none"> • Earn an additional 5% on E&M Codes • PCMH Designation by BCBSM is REQUIRED to receive the PDCM Population Management VBR. <p>(2020 VBR)</p> <ul style="list-style-type: none"> • Measurement year Jan. 1-Dec. 31, 2019 • Payment period 9/1/2020-8/31/2021 • 3% engagement rate (2 touches) required* <p>(2021 VBR)</p> <ul style="list-style-type: none"> • Measurement year Jan. 1-Dec. 31, 2020 • Payment period 9/1/2021-8/31/2022 • 4% engagement rate (2 touches) required* <p><i>*TCM codes will only count toward population management VBR when there are PDCM codes billed for $\geq 1\%$ of the population.</i></p>
<p><u>AP-VBR-Advanced Practice VBR - <i>No Longer Available</i></u></p> <p>Metrics in 2019 were:</p> <ul style="list-style-type: none"> • Opportunity for additional 5% on E&M codes only after obtaining the PDCM VBR • Measurement year Jan.1-Dec. 31, 2018 • Payment period 9/1/2020-8/31/2021 • 5% Engagement rate required • Must obtain PDCM-VBR designation by BCBSM to be considered 	<p><u>NEW - PDCM Outcomes VBR</u></p> <ul style="list-style-type: none"> • Each component is worth a potential 1.5% VBR • Quality and Utilization components are measures to earn additional VBR • All PDCM PCP practice units are eligible to receive the PDCM Outcomes VBR based on performance or improvement; does NOT require a PDCM Population Management VBR. <p>(2020 VBR)</p> <p>A total of four metrics will be used to determine the additional outcome VBR. Performance will be evaluated at the Sub-PO level; in the future there may be opportunities to measure at the practice unit level based upon the size of the practice.</p> <p><u>Two Quality Metrics:</u></p> <ol style="list-style-type: none"> 1. Blood pressure control (HEDIS) weighted 1.5% 2. HgbA1c control in Diabetes (HEDIS) weighted 1.5% <p><i>Total Quality VBR Opportunity= 3%</i> <i>Quality metrics apply to adult population only.</i></p>

	<p><u>Two Utilization Metrics:</u></p> <ol style="list-style-type: none">1. ED Utilization Rate - weighted 1.5%2. Inpatient Discharge Rate (non-Maternity, risk adjusted) weighted 6.5% <p><i>Total Utilization VBR Opportunity=8%</i></p> <p><i>Utilization metrics apply to both adult and pediatric populations.</i></p> <p><u>Two methods to receive VBR for all four measures:</u></p> <ol style="list-style-type: none">1. Performance against a national benchmark (i.e. Milliman loosely managed benchmark) <p>OR</p> <ol style="list-style-type: none">2. Improvement measurement based on opportunity to improve benchmark (improvement methodology is currently under development by BCBSM).
<p><u>Note:</u> <u>Specialists and non-PCMH designated practices participating in CPC+ may bill for the PDCM codes but do not qualify for VBR consideration.</u></p>
